Revenues from the sales and services tax shall be allocated as follows: Fifty percent (50%) FOR PROPERTY TAX RELIEF.


The specific purpose for which the revenues shall otherwise be expended is: Fifty percent (50%) for bridge and roadway culvert repair, inspection, upkeep and replacement.
