- If you mark the ballot for more choices than permitted, that contest or question will not be counted.
- Write-in Votes:** To vote for a person whose name is not on the ballot, write the name in the write-in space and fill in the oval next to it.
- Do not write in a candidate's name if that person's name is already printed on the ballot for that same contest.
- Before casting your ballot, if you make a mistake or want to change your vote:** return your ballot to an election official and get a new ballot. You may ask for a new ballot up to two times.
- After voting:** put the ballot into the secrecy sleeve and insert it into the scanner on top of the ballot box.
